#### 21<sup>ST</sup> CENTURY BORDER ACTION PLANS

While the North American trade discussion has recently been scope-locked on the renegotiation of NAFTA, the subsequent tariffs, and the resulting (potential) new tri-lateral USMCA, NASCO has been working to drive home the fact that while free trade agreements are vital, they are not the only consideration for those shipping between Canada, the US and Mexico.

NASCO, for 25 years, has been a constant advocate for solutions to improve our continental global competitiveness, enhance security and provide increased efficiencies for North American trading partners.

It is in line with this approach that NASCO partnered with the Business Council of Canada in late 2018 to release the 21st Century Canada - US Border Action Plan, and will release our own 21st Century US-Mexico Border Action Plan in early 2019. from doing business together. NASCO brings Both action plans outline short, medium and long term solutions to make cross border trade more efficient, more secure and more competitive on the player on the global trade stage. global stage.

Elements such as resources, technology, and harmonization are common themes throughout both plans. Sadly, and not surprisingly, many members and contributors to the plans agree several of the short-term recommendations have been at play, without resolution, for nearly twenty vears.

NASCO is pleased to continue to generate discussion and evolve both plans to support North American trade efforts, and to work collaboratively with our tri-lateral partners in government, industry and beyond to implement realistic. inexpensive, do-able ideas.

With federal politics in a near constant state of flux, it is important to not lose sight of the inefficiencies and barriers that layer cost, increase frustration and deter North American partners much needed attention to these issues and promotes North America as a truly competitive

#### SUPPLY CHAIN

The NASCO Supply Chain Council is committed to addressing the challenges that exist on freight networks and across our borders. The Council continues to explore innovative ways to advance trade efficiency and security, because the North American supply chain is vital to our competitiveness in the global economy.

#### WORKFORCE

The NASCO Workforce Council holds a tri-national vision for harmonized manufacturing and logistics worker training and certification standards in the USA, Canada and Mexico for job training and placement. We work to coordinate efforts and implement ideas - both domestically and internationally - to strengthen North America's talent pipeline.

#### ENVIRONMENT

The NASCO Environment Council promotes initiatives supporting new technologies and approaches to improving environmental impacts resulting from trade across North America, and is a huge advocate for continental energy security and independence.
