## Frank White Jr. Jackson County Executive

Frank White, Jr. has proudly served as Jackson County Executive since 2016. He is the first African-American to hold the position and is committed to building a better and more equitable community. His vision to achieve that goal is rooted in the County's signature program, *Our Healthy Kansas City Eastside*, which addresses health care inequities on the city's eastside by increasing *access to COVID-19 vaccines and preventative health services. Additional accomplishments include providing fair, living wages to county staff, comprehensive fertility services and expanded paid parental leave.* A proud product of Kansas City's eastside, County Executive White played 18 years with the Kansas City Royals and is enshrined into the Royals Hall of Fame at Kauffman Stadium. Before the major leagues, one of his first jobs was a union laborer working on the upper deck of the unfinished baseball stadium. That gives him the distinction of being the only Major Leaguer to play in a stadium that he literally helped build. Now, he serves as the Chief Executive of the county that owns the stadium.
